MINUTES**Public Participation**

Members of the public were invited to make representations to the Council on any matters relating to the work of the Council or to raise any issues of concern. The following matters were raised;

- 1 Bimport- Concern was expressed that North Dorset District Council had already granted permission for the planning application before consultation with Shaftesbury Town Council. Work has already begun on this project.
- Church Lane- Concern was expressed that work was already underway on this plot before planning permission had been granted. The comment was made that this is a listed building and wall that faces the Abbey and nothing on the outside should be touched.
- It was reported that the January issue of the Gillingham and Shaftesbury News is now published.

- Concern was expressed that there was incorrect information on the Shaftesbury Town Council website. Assurance was given that this is in hand.

F94c 2/2017/1636/FUL Extension A Ivy Cross Shaftesbury Dorset- **No Objection**

F94d 2/2017/1284/FUL 1 Bimport Shaftesbury SP7 8AT and 2/2017/1285/LBC 1 Bimport Shaftesbury SP7 8AT- **No Objection** (based on the revised drawing 449057) and providing parking for residents of the flats.

F94e 2/2017/1724/LBC Land On The South Side Of Church Lane Shaftesbury Dorset SP7 8JT and 2/2017/1725/FUL Land On The South Side Of Church Lane Shaftesbury Dorset SP7 8JT- **Objected** due to the following reasons; The plans being out of keeping with the appearance and character of the area. The need to protect special areas, this site borders a Scheduled Ancient Monument site. There is no Highway access to the site. The committee requested this to be considered by the North Dorset Planning committee and not delegated. It was agreed to write to all Shaftesbury ward members and any potentially interested parties regarding this application to receive comments also. It was agreed that the arrangement for current properties regarding access from Park Walk be researched to find out what arrangements for easement have been previously granted by Shaftesbury Town Council as the owner of Park Walk.
