3 Christy's Lane Traffic Study

To consider commissioning a traffic study in relation to Christy's Lane and the Shaftesbury bypass

3.1 Recommendation

3.1.1 The Planning and Highways Committee recommends that the Council commissions a traffic study to demonstrate any improvements required to Christy's Lane or if there is a need for the Shaftesbury Eastern Bypass.

3.2 Background

3.2.1 The Planning and Highways Committee have recommended that £5,000 is spent to carry out a study of the current and future traffic implications for Shaftesbury resulting from the proposed developments identified in the local plan for Shaftesbury and Gillingham.

3.2.2 The anticipated cost of this work is £5,000. Report 1117PH5 of the 21st November 2017 refers.

3.3 Strategic Plan Link

3.3.1 Both the bypass and future infrastructure needs are referenced in the strategic plan. Economic development and physical regeneration projects **also** both feature heavily in the strategic plan. Consideration need to be given to understand the impact of the proposed bypass with the need to create and sustain a thriving economy within the town. **How** will the bypass attract more visitors and more shoppers by complementing and enhancing the business community within the economic landscape in line with the strategic plan aspirations?
