# **MINUTES**

## 2014/28 Apologies for Absence

### 2014/29 Declaration of Interests

Members and Officers were reminded that at the start of the meeting they should declare any known interests in any matter to be considered, and also during the meeting if it becomes apparent that they have an interest in the matters being discussed. (Local Government Act 1972 and Localism Act 2011). Cllr Dibben declared a personal interest in the Football Club.

# 2014/33 Grounds Depot

Cllr Tippins reported that a schedule of works had been prepared by Cllr Proctor in order to utilise the old changing rooms for the grounds team as an interim measure. It was further *AGREED* that following departure of the Temporary Town Clerk, to seek advice from a neighbouring Town Clerk as required in accordance with the resolution to support peer review of Council's governance arrangements as resolved on 7<sup>th</sup> January 2014.

It was **AGREED** to ask the same Town Clerk if they would be an independent member of the interview panel.
