BARTON HILL RECREATION GROUND

1. Purpose of Report

To consider a recommendation from the Recreation, Open Spaces and Environment Committee (ROSE) for the purchase of additional recreation equipment for Barton Hill Recreation Ground.

2. Recommendation

- 2.1 That the Council places a contract with Wicksteed Leisure Limited, for the purchase of an eight-piece Outdoor Gym and associated work for installation at the Barton Hill Recreation Ground,, to the value of £25,500 plus VAT.
- 2.2 That the Council requests North Dorset District Council to approve the drawing down of Section 106 funds to allow for a contract be placed with Caloo Limited, for the purchase of a Multi-Active Wall for installation at the Barton Hill Recreation Ground, to the value of £17,500 plus VAT, and that subject to approval, the Town Clerk be authorised to place a contract for the same.

3. Background

- 3.1. At its meeting on 17th November 2015, the ROSE Committee agreed to pursue investigating new equipment to be installed at Barton Hill Recreation Ground. Site visits were held with four providers and design concepts and quotations requested.
- 3.2. The old trim-trail equipment has been identified as in need of replacement. Those items identified as moderate risk have already been removed.
- 3.3. It is usual for quotations to be anonymised for the purposes of being considered by the Council or its Committees. However, in this instance, the providers were asked to provide their design concept and therefore the quotes are unable to be like-for-like and are bespoke to each supplier. Design concepts will be displayed during

4. Financial Implications

- 4.1. In view of the value of these contracts, the ROSE Committee is referring them to the Council for approval. Financial Regulation FR 1.32 requires that the Council itself (not a Committee) approve expenditure over £5,000. It is also required to approve expenditure which will result in the approved budget being exceeded.
- 4.2. There is £22,900 in s.106 funding for outdoor sports identified for use only at Barton Hill, Shaftesbury School and Wincombe Recreation Ground. NDDC's S.106 Officer attended the meeting of the ROSE Committee and confirmed that he would in principle, support the proposal to release S.106 money to fund the Caloo Multi-Active Wall.
- 4.3. Quotations were considered by the Recreation, Open Spaces and Environment Committee on 2nd February 2016. During the meeting it was explained that the two of the suppliers had provided amended quotations from those shown in the circulated report. The amended prices are shown in the table below.

JUBILEE PATH

1. Purpose of Report

To consider a recommendation from the Recreation, Open Spaces and Environment Committee (ROSE) for facelift work to the Jubilee Path.

2. Recommendation

That the Council places contracts for specialist facelift work on the Jubilee Path, to the value of £25,500 plus VAT.

3. Background

- 3.1. At its meeting on 26th January 2016, the Council approved a Member Motion to vire funds to allow this facelift.
- 3.2. The Chairman of the ROSE Committee presented a report to that Committee at its meeting held on 2nd February 2016 recommending an overall scheme.
- 3.3. It was agreed to break down the original quote into three parts (1) removing the rebuild of the steps either side of the slide. This task was already on the Grounds Team's work schedule to be replaced with concrete, in response to a recommendation following a Health and Safety Inspection; (2) some parts of the work could be deferred and might be within the ability of general contractors, for which three quotes would be sought and brought back for consideration at a later date; (3) other work which was felt to justified as an urgent requirement for the Civic Day on 21st February 2016 and, in respect of which, the Committee noted the advice of a member of the Open Spaces Group that the nature of this part of the work required specialist contractors.
- 3.4. The Town Clerk advised that the Council could resolve to suspend the Financial Regulation requiring three quotes for urgent and specialist work.
- 3.5. The contractors who supplied the original quote were able to supply an amended quote for the work identified by the Committee as urgent and specialist **Appendix A**.
