MINUTES

Public Participation

Members of the public were invited to make representations to the Council on any matters relating to the work of the Council or to raise any issues of concern. The following matters were raised;

- Advertising – it was reported that Shaftesbury Civic Society was fully supportive of removal of advertising signs, in particular those at the Tesco Roundabout.
- Lighting – It was reported that Shaftesbury Civic Society hoped that an amicable final decision could be reached.
- Dinah's Hollow – a representative of the Shaftesbury Tree Group stated that the group was keen that the Town Council continue to 'hold the line' in seeking to protect the hollow in view of its ecology, history and value to the local economy.

The Committee extended its sympathies to the people of Brussels, following the bombings earlier in the day.

PH92 Apologies

Apologies were accepted from Councillor Austin due to personal commitments and Councillor Brown due to vacation.

PH93 Declarations of Interest and Dispensations

Councillor Proctor declared a Disclosable Pecuniary Interest in planning application 2/2016/0096/LBC - 6 Love Lane - as his company was the architect.
