## **Supporting Information for Agenda Item 3**

- A substantial majority of Councillors now believe that the behaviour and leadership style
  of Cllr R Tippins and Cllr K Tippins is damaging the performance of the Council. Whilst
  there is no doubt about their positive contribution to both corporate business and civic
  duties, their autocratic manner, unpreparedness to hear others' views and inability to
  take advice is undermining other members' patience and morale.
- 2. This situation has been unresolved for 18 months, despite continual efforts to convince the Cllrs Tippins of their faults. Following the chaotic abandonment of the 25 October Full Council Meeting, 9 Councillors handed them both a letter (see Appendix A) giving notice that no more of this behaviour would be tolerated.
- 3. The deadline for their response has now passed, and the purpose of this meeting is to formally and publicly ask them both to resign their Chairmans' and Vice-chairman's roles as detailed below. Due notice has been given of the following two motions:
- (a) This Council has no confidence in the ability of Cllr Richard Tippins to perform his role as Mayor and Chairman of Shaftesbury Town Council in an objective and balanced way. We therefore ask him to resign from this role immediately.
- (b) This Council has no confidence in the ability of Cllr Karen Tippins to perform her role as Chairman of Shaftesbury Town Council's Recreation and Open Spaces Committee or Vice-Chair of the General Management Committee in an objective and balanced way. We therefore ask her to resign from these roles immediately.

# Appendix A. Letter to Cllr R Tippins & Cllr K Tippins

Dear Cllr R Tippins and Cllr K Tippins,

We, the undersigned, are writing formally to convey our collective decision to take the action, outlined below, which we feel is necessary to safeguard the future of the Shaftesbury Town Council.

Since this Council was elected in 2015, we have made many suggestions for a better working environment and the proper inclusion of all members in all matters. Every one of these has been ignored. We have also witnessed your unacceptable treatment of Town Council Officers in public meetings. We are no longer prepared to tolerate this behaviour.

Therefore, it is with deep regret that we formally require that:

Cllr R Tippins resigns as Mayor and Chairman of Shaftesbury Town Council, as well as relinquishing any Chairmanships or Vice Chairmanships he holds within Council committees;

and

Cllr Karen Tippins relinquishes any Chairmanships or Vice Chairmanships she holds within Council committees;

We will give you seven calendar days to act on this requirement. If you comply, then the matter will be closed and we will look forward to a period of better relations between members as well as between members and officers.

Should you not wish to comply, for the purposes of STC's Standing Order 6.a, we ask Cllr R Tippins as the current Chairman, to indicate your willingness to convene an Extraordinary Full Council meeting, at which we intend to propose a vote of No Confidence in your ability to perform the above roles. At that meeting we will also make this letter public. If you do not convene a meeting as requested, we hereby give notice that we will do it ourselves under Standing Order 6.b.

The next stage of our action will then be to absent ourselves from all Shaftesbury Town Council meetings, with the exception of the non-controversial business that the Council has a statutory duty to transact.

We believe this to be a fair course of action that, if you choose, allows you both to resign your positions of authority within the council quietly and respectfully.
