Appendix B

2/2017/0259 – Black-thorn, Salisbury Road, Shaftesbury SP7 8NL

T1 - Beech - Crown lift by 1.5m over the driveway. Reduce laterals growing over the neighbouring property by 2m. Crown thin the canopy by 10%.

The owner is worried about the lower laterals overhanging the neighbouring property close to the roof; a 2m reduction would lessen the likelihood of branch failure and damage to their property. The drive is getting covered in moss and the owner says it gets very slippery, a crown lift and thin would allow better wind filtration through the canopy helping the tree to dry out naturally quicker.

Shaftesbury Tree Group have made the following comments:

This is one of two 60-70 foot high beeches on Salisbury Road in the gardens of The Barn and Blackthorn Cottage. Together with the copper beech tree at 5, Butt's Knapp on the other side of the road, they appear to form an archway over the road - a superb entrance to the town. They are rightly protected by TPOs and are on the Shaftesbury Tree Group's list of 50 Significant Trees.

Photos 1 and 2 show that the lower branches are not near the roof of Butts Knapp Cottage, so we do not think that crown lifting over the driveway or reducing the laterals over the roof of Butts Knapp Cottage are required. We also feel that crown thinning the canopy is not necessary - and the more the tree is cut, the likelihood there is of fungal disease. Moss growth is endemic to this misty hilltop town under trees or not.



These trees, apart from their attractiveness, do a valuable job in processing air borne pollutants, buffering sound and sheltering from winds.

According to Peter Wohlleben in 'The Hidden Life of Trees" (Greystone Books, 2015), "Beeches react badly when thick branches are sawn off", and pruning wounds can fall prey to harmful fungal infections. Tinkering with the canopy of a tree for reasons that are not vital can be counterproductive and be detrimental to the health of the tree.

We are opposed to this application.

2/2017/0298 – St John's Burial Ground, Bimport, Shaftesbury

G1 - Laurel - Reduce by 2m.
T27 - Hazel and Sycamore, growing together - Coppice
T28 Hazel - Coppice
T2 - Goat Willow - Cut back side limb over road by 6m. Prune back surrounding side limbs over Yew by 2m.
T17 - Goad Willow - Coppice.

T14 - Unspecified - Remove lowest western growing limb.

Shaftesbury Tree Group have made the following comments:

Coppice hazel x 2, sycamore and goat willow. Prune back branch of goat willow that is growing over the road and the branches that are growing into the old yew tree. Reduce laurel hedge by 2m.

This application, supported by Shaftesbury Tree Group, is part of the ongoing tree management in the churchyard. This includes:

i) very gradually giving the ancient yew tree more light by thinning/removing trees around it

- ii) cutting back cracked/dangerous branches
- iii) removing dead/dangerous trees
- iv) maintaining views over the Blackmore Vale through the tree canopy

The proposed works listed above mainly concerns safeguarding the health of the Shaston Yew, the ancient yew tree on the north side of the churchyard. At the moment, saplings and laurel hedges on either side of it are shading it out. Old yews do not respond well to sudden changes in light levels or in their microclimate, so it is necessary to clear the space around them gradually.

Permission is also being sought from Historic England.

T1 - Maple - Pollard, removing all branches 3m in length

Shaftesbury Tree Group have made the following comments:

We are not sure if the tree that can be seen in the back garden of 41 from the junction of Salisbury Street and Great Lane is the tree in question, and are not sure what "removing all branches 3m in length" means. We are happy if the work is not detrimental to the tree.



PROPOSED TEMPORARY ROAD CLOSURE OF FRENCH MILL LANE, SHAFTESBURY

I have received an application from Wessex Water, to close FRENCH MILL LANE, SHAFTESBURY in three phases, between its junction with Gasgoignes Lane and Number 26, French Mil Lane, an overall distance of approximately 350 metres. The closure has been requested to allow Wessex Water to carry out three service repairs in the highway. These works are programmed to commence on Monday 20 March 2017 for 5 days with an end date of Friday 24 March 2017. The road closure is necessary for safety reasons, as the works will take place within the whole width of the carriageway.

Wessex Water will publicise the road closure in a number of ways: they will place information boards on the road in this area to inform the traveling public of the works; they will carry out a letter drop to local residents directly affected by the works; and they will sign a vehicular diversion route using the local road network. The following map shows the extent of the closure and the diversion route.

THE NORTH DORSET DISTRICT COUNCIL PUBLIC FOOTPATH NO.3 (PART) SHAFTESBURY PUBLIC PATH DIVERSION ORDER 2017

The above order was made on 15th February 2017. The effect of the order will be to divert the public footpath running from point A, Ordnance Survey ("OS") grid reference ST 87149, 24140 in a north-north easterly direction for 8.5 metres to point B, OS grid reference ST 87153, 24147, then continuing in a west-north-westerly direction for 29 metres to point C, OS grid reference ST 87126, 24159, the junction of Footpath 3 with the public highway, to a line running from point A, OS grid reference ST 87149, 24140 in west-north-westerly direction for 27 metres to point D, OS grid reference ST 87123, 24149, a point on the public highway, as shown on the order map.
