### **Public Participation**

Members of the public were invited to make representations to the Council on any matters relating to the work of the Council or to raise any issues of concern. The following matters were raised:

- Housing North East of Shaftesbury opposed to the development.
- Neighbourhood Plan looking for an update on the Neighbourhood Plan. The Chairman of the Neighbourhood Plan Group provided a brief update expressing the aim for public consultation in June and July of this year.

Apologies were received and accepted from Councillors Loader, Perkins and Todd due to conflicting engagements, County Councillor Jeffery due to ill health and apologies for being late from Councillors Hall and Jackson.

#### FC157 Minutes

It was **RESOLVED** to approve the minutes of the Full Council meeting held on the 7<sup>th</sup> March 2017 and the minutes of the Extraordinary Full Council meeting held on the 28<sup>th</sup> March 2017 as a correct record. The minutes were duly signed.

#### FC158 Order of Business

It was **RESOLVED** to move item 12 Land North East of Shaftesbury and item 7 Strategic Plan to directly follow item 4 Reports.

# FC159 Reports

Officer report 0417FC04 was received and noted. The Chairman expanded on his report enclosed within the documents, District Councillor Beer was available to answer any questions. Apologies were received from County Councillor Jeffery. A vote of thanks was extended to County Councillor Jeffery for his work at all tiers of local government.

Councillor Proctor reported on the Abbey.

Melbury and Cann Group Parish Councillor William Kenealy provided a report as Chairman of the Neighbourhood Planning Group in addition to the previously circulated report.

Councillor Cook expressed thanks on behalf of the Shaftesbury Snowdrops for the grants received. The group is looking for a sponsor.

### FC160 Land North East of Shaftesbury

Officer report 0417FC12 was received. It was reported that both North Dorset and Wiltshire Councils had confirmed that they currently had adequate land supply allocated for building. Discussion took place in relation to the proposed bypass corridor.

#### 7:28 Councillor Hall arrived.

It was **RESOLVED** that Shaftesbury Town Council opposes any plans for further development in the Wiltshire Highway route Protected Zone (Saved Policy TR20). That the Town Council seeks assurance from North Dorset District Council, Dorset County Council and Wiltshire Council that the by-pass route will remain protected and generally unchanged in any future local plan review process. That the Town Council seeks from Dorset County Council a continuing commitment to the Eastern Outer Bypass. That the Town Council seeks from North Dorset District Council concrete assurance that the Outer Eastern Bypass will feature in any local plan re-write. That the Town Council seeks from Wiltshire Council concrete assurance that the Highway route Protected Zone (Saved Policy TR20) will remain in force and no further development will take place within it and that the Neighbourhood Plan Group be asked to include a policy in relation to the bypass with similar effect.
