Proposed Temporary Traffic Regulation Order - B3091

Dear Sir / Madam

We will be temporarily closing the B3091 between 3rd September 2018 and 14th September 2018. The road will be closed between the hours of 09:00 and 16:00 daily, to enable us to carry out maintenance work, but will be reopened at night and at weekends.

The diversion route for drivers is marked in blue on the attached plan.

In the current financial climate, the highways service has had to focus on targeting the most damaged sections of road and areas with safety issues. We will be repairing sections of road within the area marked in red on the map.


While the road closure is in place an appropriate diversion route will be signed – as set out by Government regulations, we have to divert traffic onto the same classification of road as the one we have closed.

#### 7 Planning Policy

#### 7.1 **Summary**

- 7.1.1 Councillors have raised frustrations that current planning policy does not really provide for Town and Parish councils to influence the planning process.
- 7.1.2 Frustrations have also been expressed in relation to the 5 year land supply being determined by the houses built rather than planning permission granted.
- 7.1.3 The Committee may look at the constraints of current planning policy and make an application through the DAPTC and NALC to lobby for change.
- 7.1.4 It is the Town Clerk's understanding that many other Town and Parish Council's are also lobbying for a change to the 5 year land supply requirements and that a volume of the same requests on this topic may have greater influence.
