- F04b 2/2018/1412/LBC Mustons Yard, Mustons Lane. Erect 1 No. dwelling, revised design to 2/2013/0269/PLNG. **Objection due to limited access for service vehicles, privacy and light concerns.**
- F04c 2/2018/0411/LBC Mustons Yard, Mustons Lane. Erect 1 No dwelling, revised design to 2/2013/0268. **Objection due to limited access for service vehicles, privacy and light concerns.**
- F04d 2/2018/0422/FUL Mustons Yard, Mustons Lane. Erect timber framed building, secure frontage and interior canopy. **Support.**
- F04e 2/2018/0434/HOUSE 5 Victoria Street. Partially dismantle garage/workshop and erect replacement garage/workshop with first floor over and link to the main house. **Objection. The committee liked the design but objected to the garage doors opening onto the street.**

- F04g 2/2018/0436/FUL Fountain Inn, Breach Lane. Alterations and improvements to Public House incorporating manager/staff flat and attached house to 1 No. dwelling and carry out associated internal and external alterations. **Support.**
