#### F16 Long Stay Car Park Project 1 And 2 And 3G Proposal

F16a Officer report 0720FC4 was received and the following was **PROPOSED**;

- Delegate the management of the project plan to the Lead Councillor Alex Chase, supported by Piers Brown, George Hall and the Town Clerk and Business Manager in consultation with Dorset Council Officers and Directors of Shaftesbury Football Club and the Town Clerk be authorised to take all such steps as she considers necessary to comply with the Council resolutions insofar as they are set out below.
- Sign off the high-level project plan including milestone review dates (as presented in the PID)
- Further investigate Section 106 funding of £75,000 or more to support the project
- Support the 3G project and allocate a sum of £100,000\* from General Reserves; to be repaid by Shaftesbury Football Club using a low-cost loan to payback the funds. The repayment funds to be built in to the lease agreement. (repayment plan to start after a one-year holiday to enable usage to be maximised first)

\*Subject to review pending outcome of s.106 investigation (may be lower)
