Officer report 1120PH6 was received and it was **RESOLVED** to submit the following comments:

P/FUL/2020/00008

Location: Former Cattle Market Christy's Lane Shaftesbury SP7 8PH
Proposal: Erection of retail foodstore with associated car parking, access, landscaping and engineering works.

Support for this with the following conditions:

- **Lidl representatives to work with the Shaftesbury Tree Group regarding the species of trees to be planted**
- **The construction phase on Christy's lane to be supervised to ensure no damage to the tree roots is sustained**
- **If access to the Town Centre is not possible via the Tesco pedestrian link the car parking time limit should be a minimum of 2 hours to allow for increased travel time**

P61a 2/2020/0572/FUL

Location: Land At Raspberry Lane Raspberry Lane Shaftesbury
Proposal: Erect 1 No. dwelling, create new vehicular and pedestrian access and form 2 No. parking spaces.

Object to the scheme due to its appearance.

- **The committee would fully support the development of the site if based on the design and ecological proposals as per the plans that were submitted in August 2019.**
- **The Committee feels strongly that the land should not be left to go to seed for the sake of not removing a wall.**
- **The committee also feels strongly that a house that is determined to be eco-friendly should be welcomed in Shaftesbury.**
