

SHAFTESBURY TOWN COUNCIL

Planning and Highways Committee Informal Meeting to discuss decisions to be made under the Scheme of Delegation

Extract from Full Council minutes on 20/4/2021: That all powers related to the carrying out of council business be temporarily delegated to the town clerk until such time as the UK government roadmap reaches step 4 or the law changes to enable formal council meetings to convene online. That unofficial online meetings shall continue in line with the council's schedule and under the council's standing orders and that all decisions that would otherwise be made by the corporate body shall be brought to these meetings and that the officers shall act in line with the expressed wish of the corporate body.

Even within the scheme of delegation, not all decisions may be taken by officers. Action points within these minutes are marked to show whether they will be carried out under delegation (D) or referred (R) to a formally convened meeting for either ratification (agreeing the decision after it has been taken) or resolution (waiting on action until the decision has formally been made).

Objection on the grounds that this application contravenes almost every relevant policy in the Shaftesbury Neighbourhood Plan. Including SFHE1, SFHE2, DH1, DH7 and SFCL3.

A full and detailed objection expanding on the contravened Shaftesbury Neighbourhood Policies will be prepared by Councillors Lewer and Edwyn-Jones.

The committee requests that this application is considered by the Dorset Council Planning Committee, not delegated to officers for a decision.

It was agreed to formally write to Dorset Councillors Derek Beer and Tim Cook, and to MP Simon Hoare alerting them to this application and request that they support the request for it to be considered by committee and object strongly to this application.

SODP12 Proposed Parking Charging Strategy

Shaftesbury Town Council fully supports the response that Shaftesbury Chamber of Commerce submits. [View full response here.] Along with these following points;

 Shaftesbury should be put in the same category as Gillingham, currently the strategy puts Shaftesbury at a considerable disadvantage. Shaftesbury is also rural, with less population and less shops than Gillingham.

- Due to specific parking issues in individual towns, the committee disagrees that a 'blanket policy' is appropriate to enforce across Dorset.
- Shaftesbury has parking issues already due to the loss of 140 parking spaces when the Cattle Market was sold.
