#### **Public Participation**

**Beech Trees** – Concern was expressed regarding the removal and potential damage to the Beech Trees along Christy's Lane due to the Lidl development. (Councillor Cook is investigating this in his role as a Dorset Councillor)

**Stone Wall Repairs –** Concern regarding damaged walls on Shooters Lane was expressed. (*This is in hand with Dorset Council.*)

**Football Club –** Concern was expressed regarding the business plan for the Football Club project.
