5.1. Summary

5.1.1 The confidential information will be provided via a separate report to committee members in advance of the meeting.

5.2. Legal Authority and Implication

- 5.2.1 Without prejudice to section 111 above, every local authority shall make arrangements for the proper administration of their financial affairs and shall secure that one of their officers has responsibility for the administration of those affairs. (Local Government Act, 1972 s.151)
- 5.2.2 A body may, by resolution, exclude the public from a meeting (whether during the whole or part of the proceedings) whenever publicity would be prejudicial to the public interest by reason of the confidential nature of the business to be transacted or for other special reasons stated in the resolution and arising from the nature of that business or of the proceedings; and where such a resolution is passed, this Act shall not require the meeting to be open to the public during proceedings to which the resolution applies" (Public Bodies [Admission to meetings] Act, 1960)

5.4. Impact Assessment
