Minutes of the Planning & Highways Committee (P&H) held at 7 pm on Tuesday, 2nd August 2022 in the Council Chamber, Shaftesbury Town Hall

Minutes

Public Participation

Members of the public were invited to make representations to the Council on any matters relating to the work of the Council or to raise any issues of concern, the following matters were raised.

- On 26th July Dorset Council published a statement relating to the Dorset Local Plan. Key points relating to the publication were read out.
- The draft minutes of the Full Council meeting on 19th July were challenged as inaccurate and it was requested that the Public Participation point relating to Mampitt's Square is amended from *the land being given to STC in perpetuity* to *'land should be in public ownership in perpetuity'*. It was also noted that Minute No. FC35c is too short and does not provide sufficient information for future reference.

Post Meeting Note: The 19th July Full Council minutes have been amended for approval at the FC meeting on 17th August.

- A copy of the contract between Lidl and Dorset Council was requested via the Dorset Councillor however to date this has not been received. A greater understanding of who has responsibility for the watering and maintenance of the trees is needed.
- A discussion was held about when it would be known if these trees will survive or die, hence need replacing or not. The survival of the trees will not be understood until the Spring next year.
- The Birch trees within the car park also show sign of stress.
- It was queried how the change to the Local Plan (LP) effects the review of the Neighbourhood Plan (NP), as the LP precedes the NP. The Chairman reported that legally, until a new LP is made, this committee will refer to the LP adopted in 2016.
- Castle Hill mound, Scheduled Monument, and the slopes as well as the area leading through Breach Lane requires maintenance. It was queried if the Rangers are undertaking this job as the area is unsightly. The Town Clerk reported that the Service Level Agreement was sent to Dorset Council 18

months ago and a response is awaited. Cllr Tippins reported that the Rangers have recently carried out other maintenance areas at Castle Hill.

- The overhanging vegetation at the allotments by St John's Hill was queried. The Town Clerk will follow this up and will arrange for a meeting with the resident to look at the area.
- Cllr Tippins requested that planning application P/FUL/2022/03432 is discussed during this meeting. It was clarified that an extension of time was sought from Dorset Council, which was agreed until 7th September.
- Cllr Proctor requested that the walkway from Love Lane to St John's Hill is added to a future agenda
