# PH47 Planning Applications – to consider responses to planning applications

#### P/OUT/2022/00536

**Proposal:** Erection of up to 9 dwellings with associated highway and drainage infrastructure and landscaping (outline application to determine access only)

**Location:** Land at Lower Blandford Road

**Committee/Delegated:** Delegated **Consultation Ends:** 11/01/2023

Comment: The Town Council objects to this development on the same grounds as for the previous submission and refers to the objections provided in February 2022. Since that objection the committee would also point out that North Dorset now successfully has a 5-year land supply, even prior to this Shaftesbury had reached its 20-year housing target and therefore there is no further housing need in Shaftesbury. Shaftesbury has two large housing developments coming to fruition, one that is halfway through being build and another yet to break ground. There is no need for a further nine houses. The committee doesn't consider that one can determine an outline planning application for access without also considering the appropriateness of the proposed development. Looking at the development there is insufficient parking for nine houses and visitors. The committee has concerns about dimension of the visibility splay which they believe should be 5mx70m in a 40mph zone. There would also need to be an Arboricultural method statement to show how the development could be realised whilst taking care of the trees on this site that have been given protected status by Dorset Council, TPO/2022/0006. The committee also refers to the Shaftesbury Tree Group submission of March 2022. The harm caused by loss of amenity and wildlife habitat far out ways any possible benefit to the town.
