PH2 To receive a presentation from Persimmon in relation to a Reserved Matters Application for site south of the A30

The Persimmon representative provided general comments in response to Climate Change concerns raised in the public session;

- The economics of Solar Panels noting it takes about 7 years to break even
- o Better to insulate homes, include EVCP, air source heat pumps, better building materials.
- Orientation of houses is considered as part of the urban design however point to note that houses cannot be overheated.
- All developments going forward will have PV panels, EVCP, better insulated and air source heat pumps.

He then spoke about the reserved matters application;

- o 116 units reduced from 130
- o roads will be constructed to an adoptable standard
- DC requested strong building lines, less tarmac, more block paving, 2m footpath either side of the road, less parking on the street scene
- Curbs and highway will be installed
- o The development is designed to a 20mph limit
- Cycle link to school and entrance to site
- New and existing hedgerows for buffers and ecological benefit

Cllr Proctor left the meeting at 8.03pm.

Questions / Comments from the public and councillors

- Declining population yet building more houses Government policy, all planning applications are scrutinised and DC is the planning authority
- Residential care home or hotel not sure which one it will be yet, potential for both as there
 is interest from both
- Primary School Dorset Council identified need in this area, this will be followed up on how it will be taken forward, DC can accept or decline the proposal
- Design Quality has declined since 2003, no local identity new development will be informed by Saxon Grange development
- Build Quality not up to standard
- Landscaping drawings do not show space for trees
- Layout dense, urban layout
- o Right species of trees is important
- Query re SUDS, permeable surfaces
- o Landscape scheme integrated and fully implemented
- Can the boulevard (enhanced avenue of trees) be planted that was supposed to be planted along A30 - STC to write to Persimmon
- If DC do not choose the option of a school, would it be developed into more housing it is a
 possibility
- S106 monies, what is the amount and does it go to Cann or Shaftesbury not sure at this stage, will be included in the planning application
- o Play equipment still to be agreed
- o Management company residents are upset due to the long adoption period
- o STC to email Persimmon re management company queries

The STC comments from 2020 still stand and were as follows:

Loss of employment land 'This in contradiction to the Shaftesbury Draft Neighbourhood plan policy SFHE3 where all employment land should be protected. Design 'The size and nature of this planning application is completely out of character from other residential plots nearby. (NPPF 110d, 122e and 127) Traffic, Access and Road Safety 'Increased traffic on Wincombe Lane which is a narrow stretch of road will cause issues with traffic flow and access to current commercial plots, as there are already many commercial vehicles using this area. The traffic that would result from building works will also likely cause traffic flow issues and damage to the road. (NPPF 108 and 110d) Parking 'The plans for parking for these residential plots do not include any visitors parking which would result in parking along Wincombe Lane causing further issues for traffic flow. Noise/Disturbance 'Residential buildings that sit within industrial surroundings would result in noise and disturbance to residents from factories that are running 24/7, Therefore, significant impact on the residents and the businesses that operate within that area. (NPPF 180) Residential Amenity 'loss of sunlight to neighbouring properties, see sun path plan documentation. Site is adjacent to the Fire Station and impact of visual sightlines into the houses from the tower.
