

Minutes of the Mampitts Advisory Committee (MAC) Meeting

Public Participation

- Cllr Dibben thanked the advisory committee for getting this far with the Hub.
He noted that the formation of the Resident Association was timely, particularly with upcoming resident engagement meetings involving contractors.
A significant concern raised was the condition and management of the Sustainable Drainage System (SuDS). He stated that the SuDS infrastructure appears to be approximately 12 years overdue and suggested that both Shaftesbury Town Council and Dorset Council should have treated the matter as a higher priority. Concerns were expressed that required infrastructure had not been delivered in line with expectations.
More challenge should be directed towards Persimmon and that Dorset Council, as the Planning Authority, should be encouraged to use its powers to require completion of outstanding obligations and infrastructure.
Cllr Dibben reported that he wrote to the CEO of Persimmon seeking an explanation for the delays and issues experienced.
He enquired if consultants had been sent a letter of apology in relation to the conduct at previous meetings. The chair reported that there has been email correspondence with at least one consultant and conversations were had.

The meeting commenced at 7.01pm.

MAC17 To receive and note a verbal update on construction process

The project remains broadly on track, but construction has been delayed beyond the original target start date of 9th July due to a small number of outstanding legal and technical matters with Persimmon. Shaftesbury Town Council and Dorset Council have completed most of their required work and are continuing to press Persimmon for final sign-off.

Officers are actively chasing Persimmon and escalating concerns to senior management.

Other outstanding issues include a sum to rotavate the site if STC take this on after construction begins, possible indemnity for land contamination and as-built drawings from Persimmon for the installed drainage.

Dorset Council has confirmed that the extensive evidence pack submitted by the project team to satisfy the s106 conditions has been accepted. A particular success noted was the establishment of the Advisory Committee and resident representation, which helped satisfy governance and community engagement requirements.

Unfortunately, the application to the National Lottery was unsuccessful. The feedback indicated that Shaftesbury did not score highly enough against deprivation criteria used by the fund. The decision reflected funding priorities rather than any shortcomings in the project itself.

However, the project has secured 420 trees from the Woodland Trust and the team are still exploring other funding options.

Dorset Council will retain ownership of the Hub and land for an initial period before it transfers to Shaftesbury Town Council.

Before transfer can occur a series of Key Performance Indicators (KPIs) must be agreed. These are expected to measure the success of the Hub and potentially the green space. It was agreed to wait for guidance from Dorset Council before developing proposed KPIs.

Attention is beginning to shift from construction planning to future operation of the Hub including the proposed Operating Plan, which includes a procurement process for the café operation.

Several landscaping considerations were discussed, including wildflower planting and management of open spaces. The preservation and potential seed collection from existing teasels already growing on site was suggested and the Town Clerk will propose this to Sustainable Shaftesbury for practical assistance.

The committee stressed the importance of proactive communication with residents, including for any upcoming road closures for utility connections.

There being no further business, the meeting was closed at 7.40pm.
